


#### RESDC HOLIDAY SCHEDULE

#### ON THE ROAD TO RECOVERY, WITH LESSONS LEARNED By Chris Heiserman, 1<sup>st</sup> Vice President



We enter another holiday season still struggling to rid ourselves of the last vestiges of the pernicious pandemic. It was literally a national nightmare with tragic losses of American lives, massive job losses and social, economic, and educational upheaval for families.

We at RESDC are cautious-

ly optimistic about 2022. We hope to witness a new "normal" next year that includes a return of popular inperson events like theater outings, RESDC Roundup receptions, and Days at the Padres and Races. We are planning to schedule a patriotic Flag Day Luncheon again in the spring, a comprehensive Health Fair Picnic with the traditional barbeque meal in the fall, and a gala face-to-face Holiday Luncheon in December.

When the COVID-19 shutdown changed everything around April 2020 our Board of Directors and staff initiated Zoom meetings and made plans to continue serving our members. We closed our office but made it possible for staff to work remotely to field phone calls and handle correspondence from members; we were determined to maintain the quality of content in our newsletter (*THE NETWORK*) and make sure it was prepared, printed and distributed to every member regularly.

#### Virtual RESDC a Success

Several members of our Board and our Executive Director, Mark Nanzer, were affiliated with other organizations staging zoom meetings in the early days of the pandemic. The County Board of Supervisors, local cities and other public agencies began having online sessions. RESDC discovered it could use Zoom Video Conferencing to make available to our members the same kind of informative material and presentations we usually schedule at bi-monthly meetings at actual locations throughout the region. A significant plus associated with these "travel-less" virtual events was many more individuals could participate, including members who have moved away from San Diego County.

Our first hour-long video presentation was on July 27, 2020 labeled a "lunch and learn" event on Elder Abuse

featuring Paul Greenwood, a retired San Diego County Deputy District Attorney who led the office's Elder Abuse Unit for many years. Several dozen members attended the web presentation live, but the recorded video stored on the RESDC You Tube channel was later viewed 124 times.

We are proud to also be an official "Live Well" partner with the County's Health and Human Service Agency (HHSA). Several of the more than a dozen virtual presentations we have offered in the past year and a half have dealt with special topics of interest to retirees – like Aging and Independence services for the elderly, good mental health practices, "Medicines, Alcohol and Tobacco", avoiding common scams that target seniors, etc. All of our video Zoom webinars are available on the RESDC You Tube channel, which was launched in August 2020 and has acquired more than 100 subscribers. A link to the You Tube channel is located prominently on our website at <u>www.resdc.net</u>.

In addition to looking forward to a return to in-person events next year, and re-connecting regularly with friends and former co-workers again, our Board of Directors and staff plan to incorporate the enhanced technical capabilities developed out of necessity during the pandemic into our future operations. We feel that we've been resilient and proactive in the face of pandemic challenges. We are especially pleased that during these uncertain times we have forged a more collaborative working relationship with the San Diego County Employees Retirement Association (SDCERA) Board of Retirement and its staff led by new Chief Executive Officer Tracy Sandoval. This improvement is due in no small measure to the diligence of our RESDC Executive Director, Mark Nanzer, and President Stan Coombs, who has attended or monitored nearly every Board of Retirement meeting and kept us all up to date on COVID-19 issues in *THE NET-WORK*.

#### THEO AND EVELYN YAKEL SCHOLARSHIPS—2022 By Carlos Gonzalez, RESDC Scholarship Committee Chair



The Theo and Evelyn Yakel Scholarships are available again this year from the Yakel Scholarship Fund through the San Diego Foundation. To be eligible, the applicant must be a high school senior, an American citizen, and must plan to attend a two-year or fouryear college in the United States. The scholarship must be used for tuition, books, or fees. All children,

grandchildren or great-grandchildren of a RESDC member may be eligible to apply for the Yakel Scholarships.

The two-month application period opens December 1, 2021 and closes February 2, 2022, at 2:00 p.m. Applicants should go to <u>www.sdfoundation.org</u> and fill out the Common Scholarship Application to be considered for the Theo Yakel Scholarship as well as other scholarships they might qualify for. A sponsor certification letter verifying that the sponsor (parent, grandparent, or great-grandparent) is a **RESDC member must be attached to each application** filed. This document can be obtained by calling the RESDC office at (866) 688-9229 or sending an e-mail request to resdc@resdc.net. The foundation requires this document be verified and signed by a RESDC staff member and will not accept an application without this document.

PLEASE NOTE: All eligible high school seniors ARE ALLOWED to apply for both the Yakel and the RESDC Scholarships. Details concerning the RESDC Scholarship Program will be in the January issue of THE NET-WORK. □

**Op-Ed:** Retirement Is Expensive. Here's Why Pensions Can Help. In this piece for Forbes, National Institute on Retirement Security (NIRS) Director Dan Doonan makes a case for pensions as the solution to America's looming retirement security crisis. While this crisis is partly due to a gradual switch over the last few decades from definedbenefit pensions to defined-contribution plans, a globally aging population is also part of the issue. Doonan cites research from a new report from the Healthcare of Ontario Pension Plan (HOOPP) called The Value of a Good Pension to support his stance. Pensions work as an efficient vehicle for retirement security in three ways: "saving income earned while working for future use in retirement, growing these savings through productive investment, and converting these savings into a reliable stream of post-retirement income."

Issue Brief: What Resources Do Retirees Have for Long-Term Services and Supports? The Center for Retirement Research at Boston College recently released the first brief in a three-part series that concluded that about 20% of retirees will escape the need for LTSS and 80% will need at least a year of part-time support – with around a quarter requiring full-time support for several years. This brief, the second in the series, explores the extent to which retirees' financial and non-financial resources together could meet different levels of care needs.

The brief's key findings include:

- A growing concern is whether retirees will be able to meet future needs for long-term care without exhausting their resources.
- The analysis estimates how much support retirees could get from their family and financial resources and compares this amount to different levels of care needs.
- The results show that about one-third of retirees do not have the resources to afford even minimal care and only about one-fifth could cover severe needs.
- Not surprisingly, those who are married, better educated, and white have more resources for long-term care.
- To identify which people may have unmet needs, a subsequent brief will address whether those who will need care are the same ones who have the resources.

You must ask the See's sales team which items are selected. You need to show them your RESDC membership card for the discount. Be sure to mention that you are a member of Retired Employees of San Diego County. Occasionally a RESDC member is denied the discount by a clerk at these See's stores. When this happens, be sure to clarify that you are not an active County employee, but you're a member of RESDC. The county no longer participates in the See's group discount program. If you're still refused a discount, ask to speak to a store manager.

The gift cards are redeemable at any of the See's retail stores and for online purchases.

If you would like to purchase gift cards through the mail from RESDC, please address an envelope to RESDC, 8825 Aero Drive, Suite 205, San Diego, CA 92123. Enclose a check made out to RESDC for the number of gift cards you would like at **\$22 for each gift card**. Be sure to include postage stamps so we can mail the gift cards to you. Enclose one postage stamp if purchasing less than five gift cards. If purchasing over five gift cards enclose 78 cents of postage. If purchasing over nine gift cards enclose 98 cents of postage. #### APPLICATIONS OPEN FOR NEXT YEAR'S GRAND JURY

Looking for a meaningful way to make a difference in the future of San Diego County? Why not consider serving a year on the 2022-23 County Grand Jury. The 19-member Grand Jury serves a minimum of six hours a day four days a week from July 1, 2022, to June 30, 2023. The jurors investigate the operations of governmental programs of the County, cities and special districts and make recommendations to improve their performance.

Applications may be submitted to the Office of the Jury Commissioner between November 9, 2021, and January 14, 2022. The application form says they are seeking individuals with a flair for research and a desire to insure good government in San Diego County. Applicants must be U.S. citizens at least 18 years old with ordinary intelligence, sound judgment, good character, and knowledge of the English language.

A list of qualified candidates will be assembled, and each Superior Court Judge may nominate up to six people for jury service. In June a random drawing will be held to select a pool of 30 names, then the names of 19 people will be drawn at random to compose the grand jury. The remaining 11 names will become alternates.

Grand Jurors are paid per diem based on actual days worked (currently \$25 per day) and provided free parking and mileage reimbursement. For more information, contact the Office of the Jury Commissioner at (619) 685-6667 or visit this website: https://www.sandiegocounty.gov/grandjury/.
