### PRESIDENT'S MESSAGE By Chris Heiserman



Another longtime member of the RESDC Board of "retired" Directors has again from a veritable lifetime of public and volunteer service. Frank Bittner, our Treasurer for many, many years has left the Board to spend more time with his wife and family. Frank joined the Board in 1992 and was our longest serving veteran Member. We applaud his

tenure and huge contributions in helping RESDC grow into the popular, progressive advocacy and service organization it is today. More detailed background information on Frank appears elsewhere in this newsletter.

The American economy keeps chugging along, reportedly adding another 431,000 jobs in March. This is, of course, really good news, along with the near record low unemployment rate of 3.6%, despite the drag of a lingering pandemic and the global financial distress associated with the war in Ukraine. However, the federal jobs report in early April certainly wasn't all rosy. It was good news that employers were desperate for workers and average hourly pay increased 5.6% in the past year, according to the report; but the bad news was that for most workers salaries were not keeping up with rapidly rising inflation.

Expectations are the Federal Reserve is poised to raise interest rates multiple times over the next several months attempting to cool inflationary pressures. The big question mark? Can the Fed curb escalating inflation without severely throttling back the golden goose of economic growth? We will have a front row seat in witnessing the results in real time.

### The Pandemic Was Life-Changing for this Grandparent

We have all heard personal stories of parents and grandparents who couldn't see their kids or grandchildren in-person for many months due to cross-country distancing, COVID-19 health regulations and lock-down restrictions. But the pandemic was a surprising gift to grandparent Marc Joseph and his wife, Cathy, in Scottsdale, Arizona. Near the beginning of the pandemic, four

of Joseph's grandchildren and their parents moved from Austin, Texas and Orlando, Florida to Arizona to live with he and his wife. Two other grandchildren who already lived near them frequently visited their cousins for meals and sleepovers.

Apparently, many families chose the route of assembling extended family generations and living together to counter the loneliness and separation in a pandemic world. In Joseph's case, the six weeks he was able to spend with his grandkids, ages 1 to 8, was amazing and changed his life.

(Joseph's story appeared recently online in a blog post site called *Squared Away Blog* affiliated with the Center for Retirement Research at Boston College. The blog regularly publishes a variety of interesting material on financial behavior related to working, saving and retirement.)

It turns out the time Joseph spent with his grandkids – reading books, teaching them to listen and focusing on something other than their electronic devices – was so precious that he kept the connections alive when the children returned to their own homes. He and his wife made up stories about dinosaurs roaming their house and shared them regularly with the grandkids on FaceTime. A quote from Joseph, a former entrepreneur, in the blog post:

"As you grow older, you grow wiser. I wish I was there more often for my kids – every concert they were in, every ballgame they played. I was traveling the world. I wasn't always home. If I can spend more time with my grandkids, then maybe it's making up for what I didn't give my kids."

Joseph also suggests that more attention to grand-kids from grandparents both supports working parents and helps ameliorate the lingering negative effects of stress and isolation due to the pandemic. Wise aspirational words of wisdom for all adults.



### COLA IN EFFECT FOR SDCERA RETIREES

SDCERA retirees saw the 2022 cost-of-living adjustment for the first time in their April checks. This year, the SDCERA Board of Retirement approved the maximum COLA, which is 3% for Tiers I, II and A members and 2% for Tiers B, C and D members.

IN MEMORIAM AND TRIBUTE **DOROTHY SLOTER** 

We're sad to report that former RESDC President, Dorothy Sloter, passed away in March, one month shy of her 100<sup>th</sup> birthday. Many of our members probably remember Dorothy as she served six two-year terms as President, from 1996 through 2007.

Dorothy relocated to San Diego through Los Angeles in 1960. She worked as a court reporter in Illinois for 15 years and for two years in Los Angeles before joining the San Diego Superior Court in the same position. She retired in 1978.

After retiring, Dorothy joined the Retired Employees of San Diego County and shortly after was elected Board Secretary and Editor of the RESDC NET-WORK. Dorothy is marked as the longest-serving RESDC President on record.

As RESDC President, Dorothy closely monitored local, state, and federal agencies whose policies affect County retirees, and remained active on several state retirement associations, working for local government retirees and their interests. She helped individual retirees, spending many hours on the phone hearing about their problems and providing information and advice. She enjoyed attending many CRCEA and SACRS conferences as the Rep for RESDC.

Dorothy founded the annual RESDC Flag Day Luncheon and the annual Health Fair Picnic.

Dorothy was mother to three children, six grandchildren, and several great-grandchildren. She will be greatly missed by her family, friends, former coworkers, and RESDC members.

#### RECENT EVENTS

House passes 'Secure Act 2.0.' Here's what that means for retirement savings. The House of Representatives has passed a bill that will improve the retirement savings system for U.S. workers, moving it closer to becoming law.

The "Securing a Strong Retirement Act", also called the Secure Act 2.0, was recently approved with a bipartisan vote of 414-5. Now, the legislation heads to the Senate.

"The Secure Act 2.0 will help all Americans successfully save for a secure retirement by expanding coverage and increasing retirement savings, simplifying the current retirement system, and protecting Americans and their retirement accounts," said House Ways and Means Committee Chairman Richard Neal, D-Mass., ahead of the recent vote. "Too many workers reach retirement age without having the savings they need."

Now that it's passed the House, the legislation will be sent to the Senate for possible action.

In a stunning victory, Amazon workers on Staten Island vote for a union. Amazon workers in New York recently voted to form a union in what labor leaders are calling a "historic victory" against the U.S.'s second largest employer.

In Staten Island, New York, 2,654 warehouse workers voted yes to forming a union, while 2,131 voted no, according to a tally by the National Labor Relations Board (NLRB).

The Staten Island victory marks the first successful U.S. organizing effort in the company's history. Organizers have faced an uphill battle against Amazon, which now employs over one million people in the U.S. and is making every effort to keep unions out.

Now, the milestone vote and the grassroots approach to achieve it may well have ripple effects throughout Amazon, where other union efforts are already underway. It has the potential to motivate workers at other warehouses to unionize, labor experts say, and perhaps to rethink more conventional tactics for doing so. It could also supercharge the broader labor movement in the United States.

One week after Amazon workers at Staten Island warehouse made history by voting to form a union, Amazon is calling for a do-over election in filing that lays out 25 objections that form the basis of its appeal.

In its filing to the National Labor Relations Board, Amazon alleges how the independent federal agency's regional office which oversaw the election at its Staten Island facility, known as JFK8, "unfairly and inappropriately facilitated the (Amazon Labor Union's) victory."

When this happens, be sure to clarify that you are not an active County employee, but you're a member of RESDC. The county no longer participates in the See's group discount program. If you're still refused a discount, ask to speak to a store manager.

The gift cards are redeemable at any of the See's retail stores and for online purchases.

If you would like to purchase gift cards through the mail from RESDC, please address an envelope to RESDC, 8825 Aero Drive, Suite 205, San Diego, CA 92123. Enclose a check made out to RESDC for the number of gift cards you would like at \$22 for each gift card. Be sure to include postage stamps so we can mail the gift cards to you. Enclose one postage stamp if purchasing less than five gift cards. If purchasing over five gift cards enclose 78 cents of postage. If purchasing over nine gift cards enclose 98 cents of postage.
