## About RESDC

The Retired Employees of San Diego County, Inc. (RESDC) is a non-profit organization with over 6,500 members.

We represent all current and future San Diego County retirees, ensuring their current benefits are protected and obtaining new benefits when justified. The RESDC Board of Directors works closely with the SDCERA Board of Retirement, San Diego County Board of Supervisors, and the California Retired County Employees Association (an organization representing over 150,000 state-wide county retirees) on your behalf.

## Our Mission

Founded in 1961, RESDC is dedicated to advocating for retiree interests and providing pertinent information, social opportunities, and service for its members.

## Membership Benefits

**Advocacy.** We actively work on behalf of all San Diego County retirees, watching over and protecting their interests.

**Representation.** The 8th seat on the SDCERA Board of Retirement is elected by all retirees and has a fiduciary duty to represent all SDCERA members. RESDC is the only retiree organization recognized by SDCERA.

**Information.** Our monthly newsletter, The NETWORK, keeps members informed about SDCERA Board of Retirement actions and legislation, upcoming meetings, retiree reunions, and retirement related activities.

**Benefit Programs.** Group benefits are available through RESDC, such as competitive dental and vision programs. Additional plans available include travel insurance, pet insurance, and discounted home and vehicle insurance.

**Scholarship Programs.** Five RESDC scholarships, as well as the Theo and Evelyn Yakel Scholarships, are awarded annually to eligible college-bound immediate family members.

**Social Activities.** In addition to a summer Flag Day celebration, an autumn Health Fair Picnic and festive Holiday Luncheon, we host bimonthly meetings highlighting relevant retiree issues through professional speakers.

**Discounts.** We provide discounts to our members on See's Candy certificates and to a variety of amusement parks, movie theatres, and other attractions.

**Service.** Our office staff responds to members' needs and questions.

## Advocating for You

RESDC is a staunch advocate on behalf of all current and future San Diego County retirees, and we are proud of the benefits we have worked to obtain and protect over the decades. We helped secure health care coverage for eligible Tier I and Tier II retirees. We also pushed for a fixed-amount death benefit to be paid to the beneficiary.

RESDC is committed to strengthening its voice by partnering with like-minded advocates. We are a proud partner of the Retirement Security Roundtable, a collaboration of local and statewide organizations dedicated to collectively advocating for the protection of retiree benefits.
